## END USER LICENSE AGREEMENT

### 1. DTL Font Tools EULA

**1.1 Read this license carefully before downloading, extracting, and installing DTL Font Tools, i.e., software for creating, editing, and inspecting digital typefaces, which is developed by the Dutch Type Library. By downloading, extracting, and installing DTL Font Tools you accept the entire license and it becomes a legally binding contract between you, the licensee, and the Dutch Type Library. If you do not agree with the terms and conditions of the license and therefore refuse to accept the contractual obligation under the license agreement, you are not permitted to download, extract, and install DTL Font Tools.**

**1.2** By downloading, extracting, and installing DTL Font Tools you acknowledge that you have read and understood the license, that together with the related invoice it is the complete and exclusive statement of your agreement with the Dutch Type Library regarding the purchase of DTL Font Tools, and that your obligations under this agreement shall inure to the benefit of the Dutch Type Library and its software developers, whose rights are licensed under this agreement.

No variation of the terms of this agreement will be enforceable against the Dutch Type Library unless the Dutch Type Library gives its expressed consent in writing signed by an officer of the Dutch Type Library. By installing the DTL Font Tools you accept your own liability to comply with all terms and conditions of the license. If you do not agree completely with the license, do not download, extract, and install DTL Font Tools.

**1.3** The license is effective until terminated. The Dutch Type Library has the right to terminate the license immediately if you fail to comply with any term of the license. In addition, the Dutch Type Library reserves the right to claim punitive damages. Upon such termination you will destroy the original and any copies of the DTL Font Tools and related documentation and cease all use. You may terminate the license any time by destroying the original and any copies of the DTL Font Tools and related documentation.

**1.4** The Dutch Type Library reserves all rights not expressly granted to you under this license agreement. The license will be governed by the laws in force in the Netherlands.

### 2. DTL Font Tools, terms, and conditions

**2.1** DTL Font Tools is software produced by the Dutch Type Library for creating and modifying glyphs and font data, and containing additional technology, including but not limited to, for the generation of specific font layouts and font formats for specific operating systems. DTL Font Tools are the valuable and by copyright protected intellectual property of the Dutch Type Library and are only available directly from the Dutch Type Library and a limited number of authorized dealers.

**2.2** DTL Font Tools underlying this agreement is not sold to you, but placed at your disposal to use it. Only if you accept all terms and conditions of the license, you are granted a user right for DTL Font Tools. The user right is limited by the terms and conditions of the license. You are granted a user right for DTL Font Tools on condition that you pay the invoice that goes with the license within the term of payment. The license only becomes valid after full payment by the licensee and after it has been signed by an officer of the Dutch Type Library or of an authorized dealer. In case the invoice is not paid in time, the user right is terminated immediately and any use of the software to and from that moment is automatically unauthorized. After expiration of the term of payment, the Dutch Type Library has the right to charge interest and collection costs, and to demand the return of the software and any copies.

## 3. User rights, proprietary rights, and obligations

**3.1** The license grants you a non-exclusiv, non-assignable, limited right to use DTL Font Tools. Besides the description of the DTL Font Tools in question, you will find the exact definition of numbers of sites and workstations for which a user license is granted to you on the attached specification and invoice you received after purchasing DTL Font Tools. In case the text of the license conflicts in any way with the content of the related invoice, the invoice supersedes the license. A supplementary license from the Dutch Type Library is required for other than the specified tools, a different number of users, and other environments than stated on the attached specification and accompanying invoice.

The Dutch Type Library does not guarantee that DTL Font Tools will work properly in any environment, in particular when this is different from the specification.

**3.2** You will not make or have made, or permit to be made, any copies of DTL Font Tools, documentation, or any portions thereof, except one (= 1) copy solely for backup purposes. Any such copy of the DTL Font Tools shall contain the same propriety notice that appears on or in the original DTL Font Tools. You agree not to modify DTL Font Tools, nor to adapt it in any way to a any operating system. You agree not to create derivative software based on DTL Font Tools. You agree not to change or modify DTL Font Tools in any form or manner.

**3.3** You agree not to distribute DTL Font Tools in any way, including but not limited to as a component or sub-component of other products, nor to sell or lend in any way other than specified here.

**3.4** You agree not to use DTL Font Tools to infringe intellectual property rights in any manner, for example by modifying third-party font data without clear permission from the copyright owner.

## 4. No other rights

**4.1** The Dutch Type Library retains title and ownership of the DTL Font Tools, regardless of the form or media in or on which the original and other copies may located. This also implies that all rights to DTL Font Tools, including but not limited to the intellectual property rights on the data, copyright, and trademark, remain with the Dutch Type Library.

## 5. Limited warranty, liability, and indemnification

**5.1** The Dutch Type Library warrants that the DTL Font Tools in question is expected to work properly in accordance with specifications of the Dutch Type Library, in the environment as described on the accompanying invoice. However, the Dutch Type Library does not and cannot warrant the performance or results you may obtain by using the DTL Font Tools or documentation. The Dutch Type Library does not make any warrants of any kind, either expressed or implied, including but not limited to the implied warranty of fitness for a particular purpose. DTL Font Tools is provided 'as is'.

**5.2** You agree to indemnify and hold the Dutch Type Library harmless from and against any claims or damage which may result from your breach of this license agreement.

**5.3 In no event will the Dutch Type Library be liable to you for consequential or incidental damage, including damage from loss of business profits or savings, business interruption, loss of business information, and the like, or for claims by any party arising out of the use of, or inability to use DTL Font Tools, even if the Dutch Type Library has been informed and/or advised of the possibility of such damage.**
